Reports: ISG is working on submitting grant applications for a proposed Splash pad to be located at the Grand Mound Ballpark. The City has received a donation of \$1,000.00 from the IPR Grant to help provide an inclusive ADA compliant drinking fountain at the ballpark this spring. Street sweeping will occur this spring. The remaining fundraising goal for the LED trail lights is \$6,075.00.
