Motion by Schanze, second by Beuthien to approve a \$1,000.00 bonus to Kelvin Lange for obtaining 3 certifications for water and waste water. Ayes; All.

Motion by Beitelspacher, second by Schanze to approve the Planting Hope Grant of \$4,500.00 awarded and to authorize the City to pay Bill Andresen \$500.00 for delivery of the trees, and for Andresen to plant/stake 8 trees for the Evergreen Cemetery. Ayes; All.

Mayor Crosthwaite set a Special City Council Meeting for August 31st, 2021 at 5:30 p.m. to meet at City Hall and then to be completed by motorized vehicles throughout town to review sidewalks and nuisances.

ARPA Discussion: Additional options for using the funds for utility infrastructure, employee premium pay, and other available areas will be reviewed further at the September City Council Meeting.

Resolution 21-17 “Accept and Approve the Annual Financial Report for Fiscal Year 21 ending June 30th, 2021” was introduced by Schanze with a second by Banowetz. Roll Call: Schanze- Aye, Beitelspacher- Aye, Banowetz- Aye, Beuthien- Aye. Mayor Crosthwaite signed the Resolution.

Ordinance No. 305-2021 An Ordinance Amending the Code of Ordinances of the City of Grand Mound, Iowa, by Amending Chapter 60 Traffic Code Section 3-3-22 Stop or Yield at Intersecting Through Highways and other Intersections had the first reading introduced by Beuthien and waiving the second and third reading with a second by Schanze. Roll Call: Schanze- Aye, Beitelspacher- Aye, Banowetz- Aye, Beuthien- Aye. The Ordinance will be published in the Dewitt Observer. Mayor Crosthwaite signed the Ordinance.

Reports: A sludge judge report was completed on cell one of the sewer lagoon showing approximately 11-12 inches of sludge which does not require addressing at this time. The lights for the trails are being researched along with grants and contributions. The solar light on the flag
