Reports: Mayor Crosthwaite reported verbal complaints received about dogs at large. Crosthwaite requested the City Attorney’s opinion if public works employees can be requested to take photos of dogs and issue citations. The City Clerk is going to ask the County if they have a program that the City could contract with and inquire about a private contract for dogs at large. The splash pad is pending an estimate for installation costs.
