

RESOLUTION ON ACQUISITION OR DEVELOPMENT FOR OUTDOOR RECREATION NO. 23-09

County: Clinton

WHEREAS, the City of Grand Mound (City/County) is interested in acquiring lands or developing outdoor recreational facilities on the following described project for the enjoyment of the citizenry of

Site Name: Grand Mound Ball Park and the State Iowa.

Site Address: 300 East Street, Grand Mound, IA 52751

Project Title: City of Grand Mound Splash Pad and Park Improvement Project

Total Estimated Cost: \$ 553,601

Brief Description of Project:

The City of Grand Mound, with support from the Grand Mound Ball Club, is seeking funding to add a splash pad feature at the community's Grand Mound Ball Park. The Ball Park is recreational asset for the community, providing baseball and softball fields, sports courts, a shelter house, playground, and recently added 1/3 mile walking trail. The City and Grand Mound Ball Club are eager to provide additional recreational opportunities at the Grand Mound Ball Park through the addition of a new splash pad on the site.

AND, Land and Water Conservation Fund financial assistance is being sought for the acquisition or development of said outdoor recreational facilities,

NOW THEREFORE, be it resolved by the City Council of the City of Grand Mound that the project described above be authorized,

AND, be it further resolved that said City Council of the City of Grand Mound make application to the Iowa Department of Natural Resources to seek Land and Water Conservation Fund financial assistance from the National Park Service in the amount of 9.03 % of the actual cost of the project,

AND, be it further resolved that said City Council of the City of Grand Mound certifies to the following:

1. That it will accept the terms and conditions set forth in the NPS Grants-in-Aid Manual and which will be a part of the Project Agreement for any grant awarded under the attached proposal.
2. That it is in complete accord with the attached proposal and that it will carry out the acquisition and/or development in the manner described in the proposal and any plans and specifications attached thereto unless prior approval for any change has been received from the Iowa Department of Natural Resources.
3. That it has the ability and intention to finance its share of the cost of the project and that the project will be operated and maintained at the expense of said City of Grand Mound for public outdoor recreational use.
4. That no financial assistance has been given or promised under any other federal program or activity with regard to the proposed project.
5. That it will not discriminate against any person on the basis of race, color, or natural origin in the use of any property or failure acquired or developed pursuant to this proposal, and shall comply with the terms and intent of the Title VI of the Civil Rights Act of 1964, P.L. 88-352 (1964), and of the regulations promulgated pursuant to such Act by the Secretary of the Interior and contained in 43 CFR 17.
6. That it will maintain adequate financial records on the proposed project to substantiate claims for cost-sharing.
