RESOLUTION SETTING POLICIES AND FEES FOR

THE EVERGREEN CEMETERY

WHEREAS, the City of Grand Mound, Iowa, Code of Ordinances provides cemetery fees to be established by resolution;

WHEREFORE, the City of Grand Mound, Iowa, determined that a schedule of fees and a list of policies for the sale of plots is proper and necessary associated with administering the Evergreen Cemetery;

WHEREAS, the City of Grand Mound, Iowa does hereby propose to establish the rate of a single plot within the Evergreen cemetery at a rate of \$300.00;

WHEREAS, the City Council of Grand Mound, Iowa does hereby authorize payments in the amount of \$500.00 to a contractor for the opening and closing of a casket grave and \$200.00 to a contractor for opening and closing of a cremation grave.

WHEREAS, a notice of interment is required to be given to the Cemetery Superintendent by the funeral home or by a person on behalf of the deceased a minimum of 72 hours in advance of a burial;

WHEREAS, plots may be purchased by scheduling an appointment with the City Clerk or Cemetery Superintendent. Due to the city's inability to confirm plot availability within the Evergreen Cemetery, Blocks 1-6 in the original section of Evergreen Cemetery are not available for purchase.

WHEREAS, the enclosed list of plots in Evergreen Cemetery Blocks 7-9 shall be sold prior to the City beginning to sell plots in the newly surveyed section of the cemetery and grave spaces measure four feet by eleven feet.

WHEREAS, to request a plot be utilized by a person other than the person listed on the deed, a cemetery transfer form listed in this policy is required to be completed and filed with the City Clerk;

WHEREAS, cemetery decorations should be removed by April 15th each year; decorations may be added again after May 15th each year to allow time for the public works department to complete the annual cemetery clean up;

THEREFORE BE IT HEREBY RESOLVED, that the City of Grand Mound, Iowa, does hereby approve of, authorize and adopt these stated policies and rates.
