

**CITY OF GRAND MOUND  
ORDINANCE NO. 309-23**

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF GRAND MOUND, IOWA, BY AMENDING CHAPTER 106 SECTION 106.07: COLLECTION FEES.

BE IT ENACTED by the City Council of the City of Grand Mound, Iowa:

**SECTION 1. SECTION MODIFIED.** Chapter 106, Section 106.07 of the Code of Ordinances of the City of Grand Mound, Iowa, is repealed and the following adopted in lieu thereof:

**106.07 COLLECTION FEES.** The collection and disposal of solid waste as provided by this chapter are declared to be beneficial to the property served or eligible to be served and there shall be levied and collected fees therefor in accordance with the following:



1. Schedule of Fees. The fees for solid waste collection and disposal service, used or available, are:
  - A. For each single-family residence- \$13.00 per month.
  - B. For each dwelling unit of a multiple-family dwelling- \$13.00 per month
  - C. For each small business office approved by the City Council- \$13.00 per month.
  - D. No more than three (3) waste storage containers will be allowed per week for each property served.
  - E. Commercial premises or premises with 2-yard dumpster- \$50.00/month; with 4-yard dumpster- \$80.00/month.
  - F. 2-yard dumpsters will be charged at a rate of \$15/week; whether they are full and dumped or not.
  - G. 4- yard dumpsters will be charged at a rate of \$30/week; whether they are full and dumped or not.
  - H. The following items may be set out for recycling on Wednesdays. The charges for each item are as follows:
    - i. Appliances- \$10.00 each
    - ii. Tires off rims- \$5.00 each
    - iii. Tires on rims- \$10.00 each
    - iv. Computer Towers, CPUs, and small printers/copiers \$10.00 each
    - v. All Computer monitors and televisions (screen size 20 inch or less)- \$15.00 each
    - vi. Large copier/printers- \$15.00 each
    - vii. Televisions (screen size over 20 inches) - \$20.00 each

**SECTION 2. SEVERABILITY CLAUSE.** If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


**SECTION 3. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.


